


Recuperação de importantes indicadores de demanda no mês de Outubro de 2020

Percentual de atingimento comparativo aos mesmos períodos de 2019 (números gerenciais não auditados)




Novos Cadastros Smiles




Faturamento Total




Recovery of important indicators of demand in October 2020

Percentage of comparable achievements regarding same periods of 2019 (managerial and unaudited data)




